Terms and Conditions:

1. Payments will be held in accordance with the Consumer Protection Act, 2008 and all interest or other income therefrom will accrue to I M Smart as income. Your deposit will be refunded when your child leaves I M Smart, without interest, only when we receive full payment of your final account. The parents will not be entitled to apply any set-offs.

There are no refunds/discounts if your child misses school for any reason.

2. All fees are due on or before the 1st of every month including holiday times and December. Late payments (after the 2th of the month) will incur late payment penalty fee of R150 and interest. Fees not received by 7th day of the month will result of the child being denied access to the school until the full outstanding amount and penalty has been settled. All 30 days accounts will be handed over for collection. The charges will be for parent's account.

3. Cash deposits into our account incurs fees. Those will be for the depositor's account. We accept cash payments in the office.

4. One calendar month notice is required and accepted on the last working day of a calendar month e.g. Jan. Feb. March etc., should your child leaves the school for any reason. Last notice for the school year 2021 will be accepted on 30 September 2021 with final month for attendance being October 2021.

Notices to leave school or change from full day to half day are NOT ACCEPTED for the month of December.

5. Publication/Media consent. During the year we have opportunities to document the child's or school's activities, achievements or successes. We may take photographs, voice recordings, video recordings and other visual documentation of students.
